

Refund Policy



For cancellations; we require a minimum of two weeks notice. Notice period starts at the beginning of the week (ie. Monday or the following day after a holiday). If notice is given in the middle of the week; the notice period starts the following Monday or day after holiday (ie. if notice given on Wednesday July 8; the two week notice period starts on Monday July 13). The camper can attend camp for the two week notice period.

Refund Policy for week-by-week "A la carte" registrations:

A full refund (less \$50 admin fee) will be provided with an email notice of cancellation dated 21 days or greater before the next scheduled start day of the week (for 2026: Thursday July 2, any Monday, or Tuesday, August 4).

A 50% refund will be provided with an email notice of cancellation dated 14-20 days before the scheduled start day of the week (for 2026: Thursday July 2, any Monday, or Tuesday, August 4).

No refunds will be provided within 13 days of the scheduled start day of the week (for 2026: Thursday, Monday, or Tuesday).

Refund policy for 7-week/6-week bundle registrations:

If you purchase a bundled package, and you request a cancellation mid-bundle, the refund will be the total you paid plus tax less the regular value per week used including the notice period.

Example: Cancellation mid-bundle

You purchased a 7-week bundle for \$1350 plus tax = \$1525.50. On July 16, you realize that you need to cancel for unforeseen circumstances. You will be refunded the remainder of the bundle price you paid plus tax; less the used weeks at the regular rate plus tax; less the 14 days notice period plus tax. Note: once the week has started, the 14 days notice will start at the beginning of the following week.

Week 1: July 2-3 (Reg. \$130 plus tax = \$146.90)

Week 2: July 6-10 (Reg. \$260 plus tax = \$293.80)

Week 3: July 13-17 – you cancelled on Thursday, July 16 (Reg. \$260 plus tax = \$293.80) - child continues with camp

Week 4: July 20-24 – 7-day notice period (Reg. \$260 plus tax = \$293.80) - child continues with camp

Week 5: July 27-31 – 14-day notice period (Reg. \$260 plus tax = \$293.80) - child continues with camp

Week 6: Aug. 4-7 – Cancelled

Week 7: Aug. 10-14 – Cancelled

Your refund will be calculated as follows: \$1525.50 - \$146.90 - \$293.80 - \$ 293.80 - \$293.80 - \$293.80 = \$203.40

Example 2:

If you paid for the 6-week Sports & Leadership bundle, and you cancel in week 1 of Leadership camp (July 6-10), your refund will be calculated as follows:

$\$695.00 + \text{tax} = \785.35 ; less $\$293.80$ (Reg. $\$260 + \text{tax}$ for week 1 – July 6-10); less $\$293.80$ (Reg. $\$260 + \text{tax}$ for week 2 – July 13-17; notice period); less $\$293.80$ (Reg. $\$260 + \text{tax}$ for week 3 – July 20-24; notice period) = - $\$96.05$. Since there is a negative balance, no additional refund will be provided.
